PRODUCT DESCRIPTION

TK-LIQUID STAMP RELEASE is a specialized formulation for preventing stamping and texturizing tools from sticking to fresh stamped concrete and/or concrete overlays, as well as keeping stamping and hand tools free from concrete build up during use.

Features:

- Prevents concrete build-up and stickiness of stamping and texturizing mats, rollers, skins and hand tools.
- Unlike powder releases, curing compounds may be immediately applied without extra washing.
- Pleasant vanilla scent makes it suitable for both indoor or outdoor use.

USES:

Suitable for interior or exterior use on freshly stamped concrete, concrete pours, overlays and stamping/texturizing tools and equipment.

APPLICATION PROCEDURES:

APPLICATION:

TK-LIQUID STAMP RELEASE 2090 should be applied uniformly to both concrete surfaces/overlays as well as any stamping or texturizing tools which will come into contact with these surfaces. Keep surfaces and tools adequately saturated with TK-LIQUID STAMP RELEASE 2090 while working with them as allowing them to dry will inhibit the effectiveness of this product.

CLEAN UP:

Soak tools and equipment in water after use.

COVERAGE:

Apply at a rate of 150-200 square feet per gallon.

Coverage rates are provided as a guideline only. Many factors including surface texture, porosity and weather conditions will determine actual coverage rates.

LIMITATIONS:

- To be used as a tool cleaner/release only. Use only as directed.
- For use on fresh concrete surfaces only.
- Do not use on too large of an area at a time as the product could dry out and become ineffective.
- Never trowel or mix this product into plastic concrete.
